## **General Meeting Attendance Requirements**

There are eight (8) General Meetings held from August through April followed by Annual Dinner in May. These are held on the fourth Tuesday of every month and take place at the League Center at 7pm unless a special event is planned. No meeting is held in December. Provisional Meetings will mostly be held at 5:30pm on the same evenings as the General Meeting. Meeting reminders and details of special events are announced through newsletters, email updates and on our website at jlwf.org.

#### Kids in the Kitchen

The goal of the Junior Leagues' Kids in the Kitchen initiative, which is supported by The Association of Junior Leagues International Inc. and its member Leagues, is to empower youth to make healthy lifestyle choices and help reverse the growth of childhood obesity and its associated health issues. All Provisional Class members will be required to assist with **two (2) Kids in the Kitchen projects** throughout the League year. Event dates and times are to be announced at your Provisional Retreat this summer. There will be at least 5 events throughout the year and you will be given plenty of notice about the dates.

#### **Completion of Provisional Course**

All of the above requirements must be completed by April 30, 2018. All Provisional Members meeting their requirements will be voted into active membership at the Board of Directors meeting in May 2018.

#### **Absentee Policy**

Due to the amount of material covered at each meeting, Provisional members should not miss any required meetings. Any absence requires **PRIOR** notification to Kim Childs or Jaclyn Johnson, Provisional Co-Chairs.

Provisional Members are allowed two Provisional Course absences and two General Meeting absences throughout the course of the year. All fundraiser shifts must be worked or fines will be assessed according to our bylaws. If absences exceed what is allowed, the Provisional will be required to repeat the missed portion of the Provisional Course. The Provisional would then be voted into Active Membership the following year.
